1. PRESENTATION

EURO SAIN is a bactericidal **detergent, disinfectant and deodoriser concentrate** for surfaces. It has bactericidal and fungicidal properties.

EURO SAIN also has a cleaning function for washing surfaces without having to add complementary products, as well as a deodorising function that leaves cleaned areas smelling fresh and clean.

Bactericidal: EN 1040 at 1.0% on Pseudomonas aeruginosa and Staphylococcus aureus.

2. ADVANTAGES

- Cleans, disinfects and deodorises in a single operation.
- Powerful disinfectant thanks to its bactericidal and fungicidal properties.
- Leaves a pleasant and persistent scent after use.
- Compliant with the French legislation (decree of 08/09/99) pertaining to processes and products used for cleaning equipment designed to come into contact with foodstuffs (rinsing compulsory in case of contact with foodstuffs).
- **EURO SAIN** complies with EN 1040 standard.
- Contains no chlorine, no alkali, no phenol.

3. AREAS OF APPLICATION

- Sanitising of public areas (schools, nurseries, restaurants, ambulances...).
- Cleaning of premises such as slaughterhouse, stable, kennel, bathroom facilities or garbage chute.
- Cleaning and disinfection of equipment in contact with food products.
- Cleaning and disinfection of sinks, floors, bathroom facilities and all types of surfaces.
- Sanitation of sandboxes.

4. INSTRUCTIONS

Dilute the product with water.

Apply by spraying, soaking or using a mop.

Leave the product to act for 15 minutes before rinsing.

Implementation:

- **DETERGENT** for all types of premises (bathroom facilities, garbage chute...): 1 L + 100 L of water.
- **DESINFECTION** of waste storage areas, wash basins or toilets: 1 L + 50 L of water.

To achieve the best effectiveness possible as a disinfectant, it is recommended to allow a **contact time of 15 minutes**.

After application and due observance of the contact time, and prior to using the premises and/or equipment, rinsing must be performed using clear water.
